

Dear Sir,

This has reference to the gas connection being provided by Sabarmati Gas Ltd. hereinafter referred as ("**SGL**") to the members of the Association, Lapkaman hereinafter referred as ("**BVA**")

In this regard, BVA agrees to the following subject to agreement of the same by SGL in writing:


1. BVA do not have any objection in SGL or its authorized representatives for carrying out pipeline activities for providing natural gas connection to its member subject to the consent letter of the association for each and every member to be accompanied with the application form.
2. BVA shall permit authorized representatives of SGL, access to the association for the purpose of laying pipelines, making installation, after or replacement of any pipeline, inspection, maintenance and installation of equipments which is required for providing gas connection to the members of the BVA, after getting prior consent of the association. SGL shall indemnify BVA against all damages to the road or any other property of the BVA if damages are done by SGL.
3. The right, title & interest of the BVA stays intact & this letter does not give any rights to the SGL either express or implied.
4. This agreement is for mutual benefit with no consideration and shall terminate at the request of the either party by giving three months notice.
5. SGL undertakes to provide the PNG connection to every demanding member of the association provided it gets the consent of BVA & it is technically & commercially feasible.





6. BVA shall permit authorized representatives of SGL to enter upon the site for the purpose of meter reading, inspection and maintenance check ups. However BVA shall have the right to verify the identification of such authorized representatives with the association's permit letter prior to permitting such persons access upon the site. SGL shall not be liable / responsible for the entry by any unidentified persons or any imposter or person claiming to represent or act on behalf of SGL
7. SGL undertakes to repair for any damage caused to the utilities such as electricity cables, water and drainage lines and indemnifies the association and its member for any loss either direct or consequential.
